REVIEW YOUR BENEFITS: DEPENDENT COMPENSATION

30%
OR HIGHER
VA DISABILITY RATING

If you have a 30% or higher disability rating from VA, you may be eligible for more money to support your family by adding your dependents to your benefits. The fastest way to add a dependent is online through www.VA.gov

ELIGIBLE DEPENDENTS



SPOUSE

includes spouses in same-sex marriages and common-law marriages



CHILDREN

(biological, adopted, step-children) who are: unmarried and under the age of 18 OR between 18-23 and attending school full-time OR severely disabled



PARENTS

whose income and net worth are below the limit set by the law

NOTE:

Parents and spouses in common law marriages, cannot be added to your benefits online through eBenefits. To add a parent as a dependent, use VA Form 21-509, Statement of Dependency of Parents and to add a spouse from a common law marriage, submit VA Form 21-686c, Declaration of Status of Dependents.

If you didn't include your dependents in your original disability claim, file your online dependency claim as soon as you get your 30% or higher disability rating from VA.



Filing online is the fastest way to get your dependency claim.



You can get a decision in as little as 48 hours.



Log in to VA.gov with ID.me, click on your name at the top, and select Dependents from the drop down menu



Click, "Add or Remove Dependent" under the Apply section.



Fill out all the information required in the step-by-step application.
⚠ Don't leave anything blank.



Make sure all your information is accurate before you click "Submit."



VA will contact you if they have questions or need more information about your claim.

Bring supporting documents: marriage certificate, birth certificates, school verification (age 18+), and death certificates (if applicable).

DEPENDENCY AND INDEMNITY COMPENSATION

Dependency and Indemnity Compensation (DIC) is a tax-free monthly benefit paid to eligible surviving spouses, children, or parents of a service member or Veteran.

To qualify, the Veteran's death must have been one of the following:

- Occurred while on active duty, active duty for training, or inactive duty training, or
- Caused by a service-connected illness or injury, or
- Not service-connected, but the Veteran was rated totally disabled by VA for a required period of time before death

The survivor may qualify if the Veteran was:

- Rated totally disabled for at least 10 continuous years immediately before death, or
- Rated totally disabled from the date of discharge and for at least five continuous years immediately before death, or
- A former POW who died after September 30, 1999, and was rated totally disabled for at least one continuous year before death



Note: You may still qualify for compensation after remarriage if you remarried on or after December 16, 2003, at age 57 or older, or on or after January 5, 2021, at age 55 or older.

DEPENDENCY AND INDEMNITY COMPENSATION

CONTINUED

Surviving Children

If you are a surviving child, you may be eligible for DIC if the Veteran parent died in the line of duty or as a result of a service-connected illness or injury.

You must also be unmarried and either under age 18, between ages 18 and 23 and attending school, or over age 18 and permanently incapable of self-support (requiring assistance with daily activities).

Exception: A surviving spouse entitled to DIC may receive additional benefits for a child over age 18 who is also receiving DIC.

Surviving Parents

Parents' DIC is an income-based monthly benefit for surviving parent(s) of a service member or Veteran whose death was service-related. To qualify, both must be true: you are the biological, adoptive, or foster parent of the Veteran or service member. Benefits are based on income. If your countable income exceeds the limit set by law, no benefits are payable. If you live with a spouse, their income must also be included. This includes the other parent of the Veteran or a spouse from remarriage.

You may be eligible if the service member or Veteran died from an injury or illness while on active duty, in the line of duty during inactive duty training, or from a service-connected illness or injury.

We recommend contacting us if:

- The Veteran was service-connected for any condition
- The cause of death may be related to service
- You have never applied for survivor benefits

Our counselors can assist by reviewing records and preparing a complete application.



VA Disability Claims, Increases, and Special Monthly Compensation (SMC)

VA disability compensation is a tax-free monthly benefit for Veterans with conditions related to their military service. Our office assists Veterans with filing new claims, requesting increases, and reviewing eligibility for additional benefits.

New Benefit Claims

A disability claim may be filed when a condition began during service or was caused or aggravated by military service. This can include physical conditions, mental health conditions, or illnesses that developed over time. To be eligible for VA benefits, a Veteran must generally have served on active duty and received a discharge other than dishonorable. The VA looks for three key elements when reviewing a claim: a current diagnosis, evidence of an in-service event or exposure, and a connection between the two. Medical records, service records, and supporting statements are often used to establish this link.



Our office prepares and submits claims on behalf of Veterans to ensure that all required information is included and properly documented.

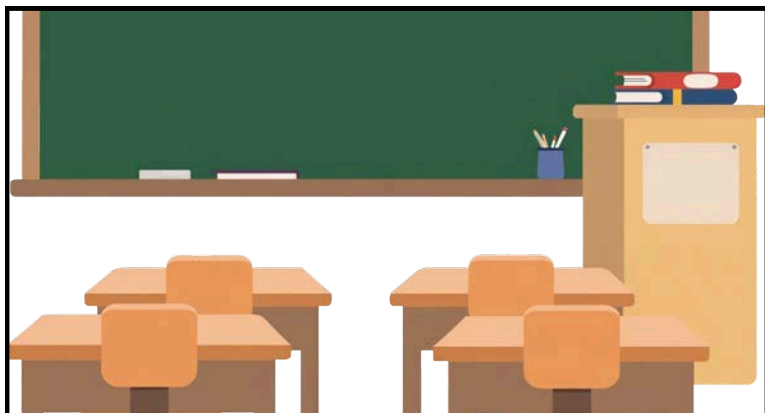
HAS IT GOTTEN WORSE?

If you are already service-connected, you may request an increased rating if your condition has worsened or if you have developed additional conditions related to your original disability. Examples may include increased pain, reduced mobility, worsening mental health symptoms, or secondary conditions such as nerve damage or sleep issues. Updated medical evidence is important when filing for an increase. In many cases, the VA will schedule an examination to evaluate the current severity of your condition. If your condition has changed since your last rating decision, it may be appropriate to have your file reviewed.

SPECIAL CIRCUMSTANCES

Special Monthly Compensation is an additional level of compensation paid to Veterans with certain severe disabilities. It is paid in addition to regular disability compensation. SMC may apply when a Veteran has loss of use of a limb, significant vision impairment, or requires assistance with daily activities such as bathing, dressing, or medication management. Aid and Attendance and Housebound benefits are two common forms of SMC. This benefit is often overlooked because eligibility is based on the overall impact of service-connected conditions, not just a single diagnosis.

UNLOCK EDUCATION BENEFITS WITH CHAPTER 35



The Survivors' and Dependents' Educational Assistance Program, commonly referred to as Chapter 35, provides education and training benefits to eligible spouses and children of Veterans. This program offers a monthly payment to help cover the cost of approved education and training programs.

Dependents may qualify if:

- The Veteran is rated 100% Permanent and Total due to service-connected conditions
- The Veteran passed away as a result of a service-connected disability
- The service member died while on active duty
- Eligible individuals include spouses and children.

What Can the Benefit Be Used For?

- College or university programs
- Technical or vocational training
- Apprenticeships or on-the-job training
- Certification and licensing programs

Benefits are paid directly to the student.

To apply:

Go to VA.gov and complete VA Form 22-5490 or submit a paper application by mail.

Once approved, the student's school will certify enrollment with the VA.

America 250: The Semiquincentennial

July 4, 1776 – July 4, 2026

In 2026, the United States will celebrate its Semiquincentennial, marking 250 years since the adoption of the Declaration of Independence.

While July 4, 1776, is recognized as the birth of the nation, independence was not fully secured until the Treaty of Paris in 1783, when Great Britain formally recognized the United States as a free and independent country.

At the time, America consisted of 13 colonies, which would go on to become the first 13 states. The Declaration of Independence was approved by the Second Continental Congress and signed by 56 delegates.

Interestingly, not all delegates signed the document on July 4. The signing process continued over several months, with the final signatures completed in January 1777.



DID YOU KNOW?

Have you ever heard someone say, “Put your John Hancock on it”? That phrase comes from John Hancock, a prominent leader of the American Revolution and the first signer of the Declaration of Independence.

Hancock signed his name boldly and much larger than the others. According to tradition, he wanted King George III to be able to read it clearly without spectacles.

Today, his name has become synonymous with a signature itself.

The courage shown by those who signed the Declaration, risking their lives, fortunes, and sacred honor, laid the foundation for the freedoms defended by generations of service members.

As we approach America’s 250th anniversary, it serves as a powerful reminder of the enduring commitment to liberty that continues through those who serve today.



If your clothing has been damaged by your prosthetic or orthopedic device (such as a wheelchair) or by the medicine you're taking for a skin condition, you may be able to get money each year to help you buy new clothes.

Am I eligible?

You may be eligible for a clothing allowance if you meet the requirements listed here.

One of these must be true:

- Your prosthetic or orthopedic device damages your clothes, or
- Your skin medicine causes damage to your outer clothing (like your pants or shirt) that can't be repaired

And this must be true:

You need this device or skin medicine because of an injury or illness related to your military service (called a service-connected condition).

Note: You must have a service-connected disability to qualify.

What type of clothing allowance is available?

To get an annual payment, or if you want to apply for an additional clothing allowance, you'll need to qualify by August 1 of that year. Applications are collected throughout the year and held until the August 1 closing date. If you qualify, you'll receive your payment between September 1 and October 31.

To Apply:

Go to [VA.gov](https://www.va.gov) and complete VA Form 10-8678 . You can also apply through your local VA medical center. Bring your application, or mail it, to the prosthetic representative at your local VA medical center.

DID YOU KNOW?



TOP 5 THINGS TO DO ON VA.GOV

Upload documents or evidence for your claim - Submit supporting records and information directly through VA.gov.

Check the status of a claim or appeal - Track progress and see updates without needing to call.

Update direct deposit and contact information - Keep your payment and mailing information current.

Download VA letters and documents - Access benefit verification letters and other records instantly.

Manage and review your VA benefits - View your disability rating, payment history, and benefit details in one place.

HAVE YOU MOVED?



You should notify the VA if you move so you do not miss important letters, exams, or deadlines. Returned mail could potentially cause an interruption in your benefits.

WHEN ZERO ISN'T NOTHING

A 0% VA disability rating means the VA recognizes your condition as service-connected, but it is not currently severe enough to qualify for monthly compensation. It is not a denial and still establishes eligibility for certain benefits, and allows for easier filing for increase if the condition worsens.

ID.me

Accessing VA.gov often requires identity verification through ID.me. Creating and verifying an ID.me account allows you to securely manage benefits, submit claims, and update your information online.

The Air Medal

The Air Medal was established on May 11, 1942, by President Franklin D. Roosevelt through Executive Order 9158, and later amended on September 11, 1942.

Created during a high-casualty period of World War II air operations, the Air Medal recognizes heroism or meritorious achievement while participating in aerial flight. It may be awarded to U.S. military members, civilians, and qualifying foreign personnel.

Who It Honors

The Air Medal is awarded for performance that goes beyond normal expectations, but does not meet the higher standard required for the Distinguished Flying Cross.

It is most often awarded to:

- Aircrew members and others whose duties require regular flight participation
- Personnel who make significant contributions during flight
- Individuals performing a single act of merit or heroism

It is not intended for routine peacetime flight operations.

Authorized Devices

- Oak Leaf Clusters (Air Force): Additional awards
- Combat “C” Device (since January 7, 2016): For achievement under combat conditions involving risk or exposure to hostile action
- Valor “V” Device (since January 7, 2016): For acts of heroism in direct combat

Service Branch Notes

- Army: Uses numerals for additional awards and may authorize the Valor device
- Air Force: Uses oak leaf clusters and authorizes Combat “C” and Valor “V” devices
- Navy and Marine Corps: Distinguish between individual and strike or flight awards, using numerals and Valor where applicable
- Coast Guard: Uses gold and silver stars for additional awards, with no extra devices authorized
